## Items for Approval

*R16-2021: Indigenous Reconciliation Action Plan – Updates and Actions* WHEREAS the Truth and Reconciliation Commission (TRC) released its final report on June 2, 2015, which included 94 Calls to Action to redress the legacy of residential schools and advance the process of Canadian reconciliation;

AND WHEREAS the recent discoveries of remains and unmarked graves across Canada have led to increased calls for all levels of government to address the recommendations in the TRC's Calls to Action;

AND WHEREAS all Canadians and all orders of government have a role to play in reconciliation;

AND WHEREAS Recommendation #80 of the Truth and Reconciliation Commission called upon the federal government, in collaboration with Aboriginal peoples, to establish, as a statutory holiday, a National Day for Truth and Reconciliation to ensure that public commemoration of the history and legacy of residential schools remains a vital component of the reconciliation process;

AND WHEREAS the Federal Government has announced September 30th, 2021, as the first National Day for Truth and Reconciliation (National Orange Shirt Day) and a statutory holiday;

THEREFORE, BE IT RESOLVED THAT the Council of the Township of Woolwich does hereby commit to recognizing September 30th, 2021, as the National Day for Truth and Reconciliation (National Orange Shirt Day) by sharing the stories of residential school survivors, their families, and communities; and further

THAT rental-related fees associated with the use of municipal parks and facilities, for recognized Indigenous organizations to lead cultural and ceremonial events, be suspended for September 30, 2021.

# **Staff Reports and Memos**

# C10-2021: Proposed 2022 Council Meeting Schedule

Council requested staff to bring back a meeting schedule with meetings moved to Monday evenings.

Council noted it was Clerk Hummel's last meeting with the Township and thanked Ms. Hummel for her service. Ms. Hummel spoke to her time at the Township being a blessing, spoke to her development during the position, thanked current and former Township employees and thanked Council for their service to the community. Mr. Brenneman spoke to Ms. Hummel's contributions to the Township and thanked her for all her years of service.

# DS26-2021: Scoped Official Plan Review – Proposed New Township Official Plan

Jeremy Vink, Manager of Planning, provided an overview of his report, including the need to bring this plan forward at this time and the need for alignment with the Region Official Plan. Mr. Vink highlighted key changes in each chapter as set out in his report. Mr. Vink noted that if Council approves these changes, the Township is requesting the Region expedite their review before they complete updates to the Regional Official Plan. Council discussed Mr. Mesina's request and asked if there was a way for Council to advocate for his request. Mr. Vink advised that there currently isn't a settlement in the area, that the lands could become part of Kitchener and the Township can comment on the Region's municipal comprehensive review which is anticipated to be brought to Council for comments in November. Mr. Vink recommended looking at requests like Mr. Messina's comprehensively. Council discussed the appropriateness of advocating for private landowners.

Council thanked Mr. Vink and planning staff for bringing this forward and discussed amending the Official Plan regarding density and sustainability. Mr. Vink advised that staff will be working on a further review considering sustainability and other items. Mr. Vink noted Council's has authority to be more demanding or restrictive than the Provincial Policy Statement and the Regional Official Plan but the Township cannot be less restrictive.

That the Council of the Township of Woolwich considering Report DS26-2021 respecting the scoped review and update of the Township Official Plan:

- 1. Adopt a by-law, to repeal the current Township Official Plan (i.e., By-law 75-2000) approved by the Regional Municipality of Waterloo (the "Region") and replace it with the proposed new Township Official Plan ("TOP") attached as Appendix 'A';
- Defer decisions for certain policies identified as Deferrals No. 1, 2, 3 and 4 of the proposed TOP pending the outcome of other concurrent and separate Planning Act processes being the Region's municipal comprehensive review of the Regional Official Plan and the Stockyard Secondary Plan Amendment No. 38 to the current Township Official Plan;
- 3. Request the Region to expedite their review of the adopted TOP and to provide a decision concerning its approval by December 31, 2021;
- 4. Pursuant to Section 22.2.2 of the Planning Act, waive the 2-year moratorium prescribed in Section 22.2.1 and thereby allow the Township to accept and process complete Official Plan Amendment applications before the second (2nd) anniversary of the first day any part of the new TOP came into effect, subject to being in conformity with the applicable Provincial and Regional planning policies; and
- 5. Consider the changes contained in the proposed TOP since the last statutory public meeting held on August 25, 2020, to be minor and does not warrant holding another statutory public meeting.
