By-law No. ###-2022

A By-law to Provide for the Appointment of an Acting Mayor When the Mayor Is Absent from the Municipality or Absent Through Illness or the Office Is Vacant (Term of Office 2022 – 2026)

Whereas Section 242 of the Municipal Act, S.O. 2001, Chapter 25, provides for the appointment of an Acting Mayor in the absence of the Mayor from the Municipality or absent through illness or the office is vacant:

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WOOLWICH HEREBY ENACTS AS FOLLOWS:

- 1. If the Mayor of the Township of Woolwich is absent or refuses to act or the office is vacant at any time during the term of Council from 2022 to 2026, each member of the Council of the Township of Woolwich whose name appears in Column 2 of Schedule "A" attached hereto is appointed to act in place and stead of the Mayor during each such absence or vacancy for the month appearing opposite their name in Column 1.
- 2. If the member named in Column 2 for the month is also absent or refuses to act or the office is vacant when called to act as Mayor, the Councillor appointed to act as Mayor for the next succeeding month who is available is appointed in place and stead of such member.
- 3. This by-law shall come into full force and effect on the date it is passed.
