Presenter Matthew Betik of KPMG provided Council with a presentation regarding the 2022 Audited Financial Statements for the Township of Woolwich which detailed:

Council members discussed dividend revenue and staff explained that greater dividends are expected in the future, how the dividends could be used for reserves, within the operating budget or into other reserve funds; and other options for Council to consider.Council expressed appreciation for Mr. Petherick and his staff and KPMG for all their hard work.

Delegations

Intimate Partner Violence - Joint Delegation

Delegates Jenna Mayne of the Women's Crisis Services of Waterloo Region, Amy Hachborn of the Waterloo Region Police Services, Lisa Akey of Camino Wellbeing + Mental Health, and Christine Taylor of the Sexual Assault/Domestic Violence Centre of St. Mary's General Hospital provided a presentation regarding intimate partner violence (IPV), which covered:

• The Culleton, Kuzyk & Warmerdam (CKW) Inquest,

- IPV Statistics Woolwich Township
- Women's Crisis Services Statistics
- Camino wellbeing and Mental Health IPV statistics and trends
- Sexual Assault/Domestic Violence Treatment Centre statistics and trends
- Recommendation and reasons to declare IPV an epidemic
- The importance of awareness, since so many victims of IPV do not report it.

Council and delegates discussed the reasons for certain demographics to be considered at greater risk for IPV, and how those issues can form barriers in seeking help.

Council expressed appreciation for the presentation and all the work that the delegates do in and for the community.

Moved by Councillor Schwindt Seconded by Councillor Bryant

WHEREAS intimate partner violence, often referred to as domestic violence, means any use of physical or sexual force, actual or threatened in an intimate relationship, including emotional and/or psychological abuse or harassing behaviour. Persons of any gender or sex can be victims of intimate partner violence; and

WHEREAS on the morning of September 22, 2015, Carol Culleton, Anastasia Kuzyk and Nathalie Warmerdam were murdered by a former intimate partner; and

WHEREAS on June 28, 2022, the jury in a Coroner's Inquest held on these deaths (hereinafter referred to as the CKW Inquest), delivered 86 recommendations; and

WHEREAS every six days in Canada a woman is killed by her intimate partner; and

WHEREAS in Ontario in 2022, 52 women, or one every week, were victims of femicide; and

WHEREAS in Ontario in 2023, year-to-date, 30 women in 30 weeks were the victim of femicide; and

WHEREAS the prevalence of intimate partner violence in Waterloo Region has continued to increase steadily over the last decade with the Waterloo Regional Police Service:

- Attending more than 66,000 calls for service, or an average of 6,600 per year and over 17 per day
- Laying more than 35,000 charges, or an average of over 3500 per year
- Investigating the homicide, attempt homicide and manslaughter of 24 people by an intimate partner; and

WHEREAS, on any given night in Canada, 6000 women and children sleep in shelters because it is not safe for them at home; and

WHEREAS racialized women and Indigenous women experience disproportionately high rates of intimate partner violence, and

WHEREAS Indigenous women are approximately 3.5 times more likely to experience some form of intimate partner violence than non-Indigenous women, and the homicide rate for Indigenous women and girls is approximately 6 times higher than for non-Indigenous women and girls, and Indigenous women are 12 times more likely to be murdered or missing than any other women in Canada and 16 times more likely than white women; and

WHEREAS violence against women costs the justice system, health care systems, social services agencies and municipalities billions of dollars per year, and municipalities are on the front lines in addressing gender-based violence; and

WHEREAS Lanark County, the City of Ottawa, the Region of Durham, Burlington City Council, the Region of Peel, the City of Toronto and numerous other municipal councils, have passed motions declaring intimate partner violence an epidemic and acknowledging the 86 recommendations made by the CKW jury;

NOW THEREFORE, BE IT RESOLVED:

THAT the Council of the Township of Woolwich:

- 1. Recognizes the issues of violence against women and girls in Waterloo Region and Woolwich Township as serious to the health and wellness of our residents and their families, and
- 2. Is committed to engaging with community partners to educate and support our residents about the seriousness and long-term danger of violence in our community; and
- 3. Declares that intimate partner violence and violence against women is an epidemic, in accordance with Recommendation #1 of the CKW Inquest; and
- 4. Request the Province of Ontario declare that intimate partner violence and violence against women is an epidemic, in accordance with Recommendation #1 of the CKW Inquest; and
- 5. Supports Waterloo Regional Council integrating intimate partner violence into the Region's Community Safety and Wellbeing Plan, in accordance with Recommendation #10 of the CKW Inquest, and set out gender-based violence/intimate partner violence as a separate priority within the plan; and
- 6. Directs staff to circulate this resolution to The Honourable Doug Ford, Premier of Ontario, The Honourable Charmaine A. Williams, Associate Minister of Women's Social and Economic Opportunity, The Honourable Parm Gill, Minister of Red Tape Reduction, Tim Louis, Member of Parliament for Kitchener—Conestoga, Mike Harris, Members of Provincial Parliament for Kitchener—Conestoga, all other municipalities in the Regional Municipality of Waterloo, the Waterloo Region Police Services Board, the Federation of Canadian Municipalities and the Association of Municipalities of Ontario.
- 7. Direct staff to make a donation of \$1000.00 to Woolwich Community Services to assist with IPV programs and services.

Middlebrook Bridge – Requests for Reconsideration

Delegates Stephanie Lines-Toohill and Mark Walker of the Save Middlebrook Bridge Group provided a history of the bridge and a background of the Save Middlebrook Bridge group, identified key areas of their advocation for bridge rehabilitation, reviewed projected rehabilitation costs, and requested that Council reconsider its decision to remove without replacement, and work with the Council of the Township of Centre Wellington, who voted to reconsider. Ms. Lines-Toohill stressed the importance of both municipalities needing to be in agreement before alternate funding avenues could be explored and explained the importance of the bridge being a transportation connector in the area.

Council inquired about what other funding options outside of the Township would the group be pursuing. Delegates responded that grants, infrastructure funding, etc. could all be explored, and the group is wiling to do that work, but that both municipalities must be in agreement before they can proceed.

Council inquired about the motion made by Centre Wellington. The delegates deferred the question to Centre Wellington Councillor Lisa MacDonald who was in attendance. Councillor MacDonald reported that at the Centre Wellington Council Meeting on July 31st, 2023, Centre Wellington staff were directed to engage with the delegate groups and Woolwich Township and for staff to report back.

Delegate Dr. Anne Crowe of the Grand Watershed Trails Network provided information on the Network, reasons why the Network wishes the bridge to remain operational, and explained why they feel current alternatives are not sufficient.

That the Council of the Township of Woolwich direct staff to continue communicating with Centre Wellington regarding the Middlebrook Bridge and that staff report back in October.

Staff reported to have had one meeting with Centre Wellington staff already and recommended that if Council wants to revisit the bridge decision, it should do so in the context of the Budget process, along with other infrastructure such as the Peel Street Bridge and amongst other budget priorities. Staff confirmed that Centre Wellington staff will be making their recommendations to Centre Wellington Council during their budget process and suggested Woolwich use the same approach.

Council expressed appreciation for both delegate groups for their presentation and the time and effort they have put forth for the community.

Item 6 on the Summary of Recommendations - Budget Parameters - 2024

Council discussed the concerns that residents have shared with them since the September 17th meeting, noting the economic challenges many families/residents are facing, and sought a further explanation from staff on the base and levy breakdown listed in the recommendation. Council confirmed that the direction was also to explore a 4.0% base to the budget deliberations.

- 3. Continues to support the concept of special levies above and beyond the base rate change, and that Council sets the amount for the increase to the Infrastructure Levy at 1.5% and 1.0% for the Climate Action Levy for the 2024 Budget.
- 4. Directs staff to propose an alternate 4.0% base change for the 2024 annual operating and capital budget, with detailed explanatory notes on what cuts would be required to achieve the 4.0% rate.
